## It's for everyone...

Chiropractic is an approved and regulated profession. Chiropractors take your medical history and diagnose your problem before treatment and are specialists who use their hands or non-invasive equipment to treat your condition. They take into account your specific symptoms, your lifestyle and your personal circumstances, in order to help you to manage your problem.

Your Chiropractor's aim is to manage any skeletal, musculoskeletal, neurological or neuromuscular condition that is treatable by chiropractic intervention. Chiropractic treatment and manipulation is not just clinically recommended for low back pain (*UK and European Clinical Guidelines for the Management of Acute Low Back Pain, 1996, 1999 and 2001*) but also for other conditions, such as:

- Neck and shoulder problems
- Joint and posture and muscle problems
- Leg pain and sciatica
- Sports injuries.

Chiropractic treatment may also provide improvement in some types of headaches including Migraine, plus infant colic and asthma.

There is a wealth of research evidence to support the benefit of chiropractic intervention for both acute and chronic disorders of the musculoskeletal system and it is illegal for anyone in the UK to use the title 'chiropractor' unless they are registered with the General Chiropractic Council (GCC).

The GCC is required by law to ensure that registered chiropractors have a recognised qualification, to monitor standards of chiropractic training, to set standards of practice and to conduct and deal with any complaints.

75,000 chiropractic patients per day in the UK can't be wrong!

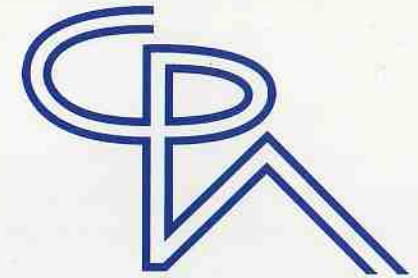
